



Terms and Conditions

These Terms and Conditions ("Terms") govern the booking and provision of photography and videography services by Noah Bliss Photography ("I", "me", "my"). By booking a session, submitting a deposit, or otherwise engaging my services, you ("the Client") agree to be bound by these Terms.

1. Bookings and Deposits

- A non-refundable deposit of 20% of the total session cost is required to secure your date. Your booking is not confirmed until this deposit is received.
- The remaining balance is due no later than 7 days before the session date, unless otherwise agreed in writing.
- Payments can be made via bank transfer. Details will be provided on your invoice.
- Prices are subject to change without prior notice, but confirmed bookings will not be affected by any price changes.
- Late payment of the balance may result in postponement of the session or withholding of final images until payment is received.

2. Cancellation and Rescheduling

2.1 Cancellation

- Cancellations made 7 days or more before the session will forfeit the deposit only.
- Cancellations made less than 7 days before the session will incur a fee of 50% of the total session cost, in addition to the forfeited deposit.

2.2 Rescheduling

- Rescheduling requests must be made at least 5 days before the session.
- I will do my best to accommodate rescheduling requests, but availability cannot be guaranteed. Your deposit will transfer to the new date where possible.

2.3 Photographer Cancellation

- In the rare event that I am unable to attend a session due to illness, accident, family emergency, or other circumstances beyond my control, I will make every reasonable effort to arrange a suitable replacement photographer of similar style and standard.
- If no suitable replacement can be arranged, you will receive a full refund of all payments made, including the deposit. My liability in these circumstances is limited to a refund of monies paid; I am not liable for any further loss or cost incurred as a result.

3. Delivery and Usage of Images

3.1 Delivery

- Images will be delivered within 4 weeks of the session date unless otherwise specified, or longer during peak wedding season, which will be communicated in advance.
- Images will be delivered as edited JPEGs via an online gallery.
- A curated, edited selection of images is provided. Unedited or RAW files are not included and are not available for purchase.
- Where a specific number of images is agreed at booking, this represents an approximate minimum; the final number delivered is at my discretion based on the quality and usability of images captured.
- I will do my best to capture all requested shots and moments but cannot guarantee every specific pose or shot list item will be achieved, due to factors such as time, light, weather, and venue constraints.
- Photography is an artistic service. The Client acknowledges that editing style, composition, colour grading and image selection remain at my professional discretion and are not grounds for rejection or refund.

3.2 Usage Rights

- Clients are granted a non-exclusive, non-transferable licence to use the delivered images for personal use only, including printing, sharing, and personal social media use.
- Commercial use of images requires written consent from Noah Bliss Photography and may be subject to additional fees.

3.3 Photographer's Rights

- Noah Bliss Photography retains full copyright over all images captured.
- Unless otherwise agreed in writing before the session, Noah Bliss Photography may use selected images for portfolio, website, social media, competitions, exhibitions and promotional material.
- Images supplied to Clients may not be uploaded to, used for, or incorporated into artificial intelligence or machine-learning systems for training, image generation or similar purposes without my prior written permission.

3.4 Albums and Prints

- Albums and prints ordered through Noah Bliss Photography are produced by third-party print labs. Estimated turnaround times will be provided at the time of order and are approximate, not guaranteed.
- Please check all proofs carefully before approving for print; I am not responsible for errors not flagged at the proofing stage.

4. Drone Photography and Videography

- All drone operations are carried out in accordance with UK Civil Aviation Authority (CAA) regulations. I hold a valid CAA Flyer ID and Operator ID.
- Drone photography is subject to weather conditions, airspace restrictions, and site-specific permissions, and cannot be guaranteed as part of any booking.
- If conditions on the day make drone operation unsafe or unlawful, I reserve the right to withhold drone footage from the session without this affecting the fee for other services provided.
- Some venues restrict or prohibit drone use; it is the Client's responsibility to confirm venue permissions in advance where drone footage is a priority.

5. Equipment and Data

- I shoot with backup equipment where possible to minimise the risk of technical failure during a session.
- While I take every reasonable precaution to protect and back up image files, I am not liable for loss of images resulting from equipment failure, memory card corruption, theft, or circumstances beyond my reasonable control.
- Image files are retained for a minimum of 1 year following delivery, after which they may be archived or deleted. I recommend Clients back up their own copies promptly upon delivery.

6. Liability

- I take the utmost care with respect to the composition, exposure, editing, and delivery of images. In the unlikely event that I fail to comply with these Terms, my liability is limited to a refund of the session fee.
- I am not liable for any indirect or consequential loss arising from my services.
- I am not responsible for any injuries, property damage, or other incidents that may occur during a session, except where caused by my negligence.
- I hold public liability insurance; details are available on request.

7. Consent and Attendees

- Where children are to be photographed, it is the responsibility of a parent or guardian to confirm consent for participation and image usage as set out in Section 3.2.
- At events and weddings, guests and attendees may appear incidentally in background images. By attending an event where I have been booked to photograph, guests consent to the possibility of appearing in resulting images.
- The Client is responsible for obtaining any permissions required by venues or landowners for photography, videography or drone operations unless otherwise agreed.

8. Privacy

- Personal information provided by Clients (such as contact details and booking information) is used solely for the purpose of delivering the booked services and will not be shared with third parties without consent, except as required by law.
- Clients may request the deletion of their personal data and image files at any time by contacting me directly; see Section 10.

9. Changes to These Terms

I reserve the right to modify these Terms and Conditions at any time. Any changes will be posted on my website and will become effective immediately upon posting. Bookings confirmed prior to a change remain governed by the Terms in effect at the time of booking.

11. Force Majeure

I shall not be liable for any failure or delay in performing my obligations where such failure results from events beyond my reasonable control, including but not limited to severe weather, natural disasters, pandemic, government restrictions, transport disruption, power failures, equipment theft or other unforeseen circumstances.

12. Governing Law

These Terms are governed by and construed in accordance with the laws of England and Wales. Any disputes arising shall be subject to the exclusive jurisdiction of the courts of England and Wales.

These Terms constitute the entire agreement between Noah Bliss Photography and the Client and supersede any previous discussions or correspondence unless otherwise agreed in writing.

If any provision of these Terms is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

By booking a session with Noah Bliss Photography, you acknowledge that you have read, understood, and agree to these Terms and Conditions.
